3.1 Switch instructions

This form is for switching funds and cash only. Should you wish to change your exchange traded investments please use our online service at fidelity.co.uk. To perform a switch please use the 'Switch from' section to let us know which of your funds you wish to sell and the percentage of each to be sold. For example, to switch entirely out of a fund please enter 100% for that fund. If you specify 40%, then we will sell 40% of your current holding. You must then use the 'Switch to' section to let us know how to invest the proceeds. For example to invest half of the proceeds into a specific fund, enter the fund details and 50%. You may specify some or all of the cash within your account to be included in the switch. Fund manager buy and sell charges may apply.

We will follow your investment instructions below, but where we cannot achieve this we will hold your money as cash within your account. This form is for investing into funds and cash only. Should you wish to invest in exchange traded investments, then please specify cash at this point. Then you can use our online service at fidelity.co.uk to make your investment later.
